And whereas, it is considered necessary to provide opportunity to those who are working in the State of Haryana and enrolled as voter in the State of Haryana and Maharashtra to exercise their franchise.


Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes 21.10.19 (Monday) to be a close day (Holiday with wages) for all Shops and Commercial Establishments falling within the jurisdiction area of the State of Haryana only for their employees who are enrolled as voters in the State of Haryana and State of Maharashtra to enable them to exercise their franchise.



And whereas it has been considered necessary to provide opportunity to the public to exercise their Franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all the adult workers working in the factories of the State of Haryana and are enrolled as the voter in the States of Haryana and Maharashtra, where General Election to Legislative Assembly are to be held on 21.10.2019 (Monday) from the operations of the provision of sub-section (1) of section 52 of the said Act, for the week commencing from 20.10.2019 and ending on 26.10.2019, subject to the condition that no adult worker who is enrolled as voter in General Election to Legislative Assembly of Haryana and Maharashtra, 2019 shall be required or allowed to work on 21.10.2019 (Monday) in the factories of the State of Haryana.


