Therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes "**Saturday**" the **30.10.2021** to be '**Close Day**' (**Holiday**) for all Shops and Commercial Establishments falling in the above mentioned jurisdiction and in the State of Haryana for only those employees who are enrolled as voters in **46-Ellenabad Assembly Constituency, 2021 (District Sirsa)**, to enable them to cast their votes.






