

The above holiday will also be a special paid holiday to the daily waged employees and also within the meaning of Section 25 of Negotiable Instruments Act, 1881.

It is, however, clarified that special casual leave/special paid holiday may be given to those employees who are working in the border areas of Sirmaur and Solan district of Himachal Pradesh but have a right to vote in the Assembly Constituencies of Haryana State, on production of certificate from concerned Presiding Officer that the employee has actually cast his/her vote.
