


## ORDER

Whereas Bye- Election to 33-Baroda Assembly Constituency Sonapat of the State of Haryana is scheduled to be held on 03.11.2020. Whereas, the Chief Electoral Officer, Haryana has directed that "Dry days" should be declared in the entire Assembly Constituency alongwith adjoining area within the radius of 3 Kms. of the area adjoining to 33-Baroda Assembly Constituency during the period of (48) forty eight hours from the closure of the poll and on the day of counting. Therefore, I, Shekhar Vidyarathi, IAS, Excise and Taxation Commissioner, Haryana, Panchkula, in pursuance of the provisions of rule 37(10) of the Haryana Liquor License Rules, 1970 and also in accordance with clause 2.13.1 of the Excise Policy, 2020-21, hereby order that the liquor vends falling within the radius of 3 Kms. of the areas adjoining to area where Bye-Election to Legislative Assembly is scheduled to be held, shall remain closed during the period i.e. 6.00 PM of 01-11-2020 to 6.00 PM of 03-11-2020 and on the counting day i.e. 10-11-2020 till counting is over.

I further order that the restrictions prescribed in the excise laws on possession and storage of liquor in unlicensed premises shall be vigorously enforced in order to ensure that storage of liquor by individuals is drastically reduced during the aforementioned period.
